Both of captioned subjects, who are brothers, are national top hoodlums who have been selected by the Department of Justice for inclusion among their top forty subjects. Since the inception of the Criminal Intelligence Program, efforts have been made to locate a possible site for misur coverage of the MANNARINOS' activities, and several previously explored target sites have had to be discarded for one reason or another.

Recently, PG 707-C, who has furnished reliable information since April, 1961, advised that SAMUEL MANNARINO is now spending the greater part of each day at his office. This office is located at 1263 Third Avenue, New Kensington, Pa., and from it, the MANNARINO brothers conduct their legitimate business enterprises, consisting of a scrap metals business, a pinball machine distributorship, a cigarette vending machine company, a bronze grave marker manufacturing company, and a company which manufactures small novelty items from scrap metals. PG 707-C states that SAMUEL MANNARINO receives numerous visitors in this office on almost a daily basis, some of whom are known to be in, or on the fringe of, racketeering activities and some of whom are not known to informant. The nature of the discussions held in the office is not known, but from years of experience gained through association with MANNARINO, informant feels confident that matters of interest to the FBI are discussed.

Informant has furnished sketches of the interior profitthe MANNARINO office and copies of keys to the outside gates and office building.
