C. ASSOCIATES

Meeting in New Kensington, Pa., December 29, 1963.

On December 29, 1963, PG T-45 advised as follows:

*Pa.* On that date, he had been alerted to stand by to drive the following men to New Kensington, Pa., that afternoon at 3:30 p.m. for some kind of a meeting: REGAL PACE, ECKLE PACE, EMIL BRYTKO and MARTY TYLER. He was to drive this group, all active in gambling activities in the North Side of Pittsburgh, Pa., to an undisclosed location where a meeting was to be held with unknown New Kensington racket figures, members of the MANNARINO organization. In addition, it was expected that SAM and JOHN CANCELLIERI and MIKE ZAPPAS, also North Side, Pittsburgh, racket figures, would be in attendance.

On December 31, 1963, PG T-45 advised as follows:

On December 29, 1963, he drove EMIL BRYTKO, MARTY TYLER and REGAL PACE to New Kensington and dropped them off on a street corner. He had gotten there by driving across the bridge into New Kensington, where he took a right turn at a car dealer's location. From there he proceeded to the first street or alley, where he turned to the left. He drove on this street to the next intersection, at which is located a red brick house on the right side corner, with a pizza shop next door to it. He dropped his passengers off on this corner and saw them enter the red brick house. Upon reaching the corner, he saw SAM and JOHN CANCELLIERI standing in front of this same house. He has not learned what transpired at this meeting and feels it would endanger his position if he should make open inquiry.

WILLIAM SAMS

*Pa.* It is noted it has been reported previously that WILLIAM SAMS, more commonly known as WILLIE SAMS,
