PG T-38 is an individual who has been connected with gambling activities in the New Kensington, Pa., area for almost 15 years.

PG T-39 is a Pittsburgh, Pa., gambler and club operator.

PG T-56 is a businessman whose activities bring him into occasional contact with members of the racketeering element in New Kensington, Pa.

PG T-58 is an individual who has been a trusted member of the East Liberty-Homewood section, Pittsburgh, Pa., numbers operation for many years.

PG T-59 is an individual who has been engaged in almost every type of criminal activity for over 25 years.
