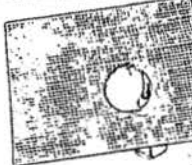

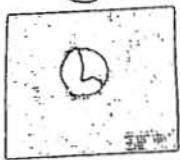

JOHN ROSSELLI, AKA. AR. PCI [REDACTED] ADVISED

THAT ABOUT NINETEEN TWENTYSEVEN, HE FIRST OBSERVED  
 ACTIVITIES OF VARIOUS RACKETEERS AND RECALLED THAT JACK  
 LA RUE, MOTION PICTURE ACTOR, LOST LARGE SUM OF MONEY TO  
 HARPO AND CHICO MARX OF MARX BROS. ENTERTAINMENT TEAM.  
 LA RUE WOULD NOT PAY AND ROSSELLI INTERCEDED AS COLLECTOR  
 OF GAMBLING DEBT. IN ABOUT NINETEEN THIRTIES, INVOLVING  
 MOTION PICTURE UNION, IATSE, PCI ASCERTAINED THROUGH  
 WILLIE BIOFF THAT LOUIS PISCOPO, AKA QUOTE DAGO LOUIE  
 UNQUOTE, LOUIE MERLI, HAD ENTERED INTO LABOR UNION BECAUSE  
 ROSSELLI HAD SO DIRECTED BIOFF. IT IS PCI-S OPINION THAT  
 PISCOPO CANNOT ACT WITHOUT INSTRUCTIONS FROM ROSSELLI.
