PH 614-C-TE advised today that he was unable to regain possession of his automobile. BRUNO refused to return car to informant. BRUNO has ordered informant to leave Philadelphia Monday, 9/21/64 for Santo Domingo, Dominican Republic, for the purpose of seeing BRUNO's associate NORMAN FROMKIN, who runs Coney Island Amusement Park, Santo Domingo.

Informant will return Philadelphia latter part of week.

Philadelphia is continuing its efforts to obtain informant's automobile for the purpose of installing CAT.

Bureau and New York will be immediately notified when the suitable opportunity presents itself.
