SUBJECT DEVOTED MORNING TO ATTENDING VIEWING, REQUIEM MASS, AND BURIAL OF AGATINA GRASSO, MOTHER IN LAW OF SUBJECT'S SISTER JOSEPHINE.

DURING AFTERNOON SUBJECT WAS IN CONTACT WITH BUREAU AGENTS, PARTIAL DETAILS OF WHICH FURNISHED BUREAU VIA TEL IN CASE CAPTIONED JOSEPH BONANNO, AKA., AR.

SOURCE ADVISED BRUNO EXPRESSED CONCERN DURING CONVERSATION WITH BUAGENTS AS AGENTS MIGHT SEARCH HIM BECAUSE HE HAD THREE THOUSAND DOLLARS IN TEN DOLLAR BILLS IN HIS POCKET.

DURING CONVERSATION COSA NOSTRA MEMBERS JOSEPH LANCIANO, FRANK NICOLETTI AND FRED IEZZI WERE LOOKING FOR BRUNO BUT WERE TOLD BY BRUNO ASSOCIATE RALPH SCHWARTZ TO LEAVE AREA DUE TO FBI PRESENCE. SUBSEQUENT TO INTERVIEW BRUNO MET WITH COSA NOSTRA MEMBERS FRANK MONTE, FRANK NARDUCCI AND FRANK NICOLETTI.
