PH 614-C-TE advised that he accompanied ANGELO BRUNO on Thursday, 11/19/64, to the home of CARL "PAPPY" IPPOLITO, Trenton, N. J., area. Present at IPPOLITO's home in addition to BRUNO, PH 614-C-TE, and IPPOLITO was JOHN SIMONE, aka. Johnny Casablanca.

For information of Offices receiving this communication, ANGELO BRUNO, IPPOLITO, and SIMONE are members of the Philadelphia Family of La Cosa Nostra. BRUNO is the "boss" of the Philadelphia Family; JOHN SIMONE is a Capodecina operating in the Trenton, N. J., area; and CARL IPPOLITO is a Soldato.

During the discussion which took place on this occasion at IPPOLITO's residence, ANGELO BRUNO apprised IPPOLITO and SIMONE of the details of three casino-type gambling operations which are for sale in Las Vegas, Nev., San Juan, Puerto Rico, and Miami-Grand Bahamas area.

(1) Concerning the casino in Las Vegas, BRUNO stated the California Club located in Las Vegas is for sale and the asking price is \$1,500,000. BRUNO stated it is controlled by a woman who is a widow (BILLYE S. LONG). IPPOLITO stated that he is familiar with the operation at the California Club and indicated the principal gambling activity at the club is slot machines. IPPOLITO stated he would go to Las Vegas and, if he could secure a working permit, he would be interested in purchasing the California Club. BRUNO indicated that the woman who controls the California Club had contacted MAX WEISBERG concerning this venture. BRUNO told IPPOLITO that he would be in contact with WEISBERG and would obtain additional information commercing the California Club for IPPOLITO.

For the information of Offices receiving this communication, MAX WEISBERG has been referred to by ANGELO BRUNO, according to PH 623-C², as the "leader" of Philadelphia's Jewish Mob. WEISBERG is known to be in continuous contact with ANGELO BRUNO.

(2) The second proposition which BRUNO discussed with IPPOLITO and SIMONE concerned a sea-going vessel named "Orange Queen" which sails between Miami and the island of Bimini, Grand Bahama Islands. BRUNO stated that this ship contains 32

slot machines. The owners of this ship are desirous of obtaining a \$25,000 loan and are willing to cut the lender in as a 50 per cent partner in consideration for the loan. In addition to the 50 per cent cut, the ship's owners will repay the \$25,000 out of their remaining 50 per cent profits. (25 per cent of the owner's 50 per cent earnings will go toward the \$25,000 loan until fully paid.) When the loan is completely paid, the lender will continue to control 50 per cent of the ship's ownership.

IPPOLITO, according to PH 614-C-TE, was very much impressed with this proposition and indicated he will send either his brother or brother-in-law to Chicago for the purpose of learning how to repair slot machines. Upon his return from Chicago, either IPPOLITO, IPPOLITO's brother or brother-in-law will go to the Miami area and will look into this proposition.

(3) The third proposition which BRUNO discussed with IPPOLITO and SIMONE concerned a gambling casino which exists in a Hilton hotel in San Juan, Puerto Rico (hotel reportedly was recently acquired by Hilton chain). The Hilton hotel chain reportedly is looking for someone to manage or lease the casino. BRUNO told IPPOLITO and SIMONE if they are interested in the casino concession at the San Juan, Puerto Rico, Hilton Hotel, they should contact JOHN SCARNI (phonetic), who is familiar with the Hilton deal. SIMONE asked BRUNO if SCARNI is "connected" and BRUNO stated that he was not. It was not clear to informant if SCARNI personally advised BRUNO of this situation or whether SCARNI had sent the information to BRUNO through an intermediary.

Friday evening, 11/20/64, source advised that MAX WEISBERG telephonically spoke with a person referred to as AL GERBER (phonetic) and stated that he had spent the afternoon with "the big guy." (WEISBERG is known to refer to ANGELO BRUNO as "the big guy.") WEISBERG told GERBER that "the big guy"
