ALESSI is a Maresciallo in the Italian Navy, resides at Viale Tirreno 187, Rome, Italy, with another en-trance to his residence at Via Val Sesia 55, Stairway 6, Apartment 6, and is assigned phone #892.1855. ALESSI has resided at this address for approximately eight years. He has lead a law abiding life in general and has no record with the INP. PAT MASSI is identified as GENNARO MASSI, the former proprietor of the apartment located at Viale delle Provincie 116, Apartment 19, Rome, where phone #426.312 was assigned. MASSI sold the apartment more than a year ago to one ELISA POLIMENI, who resides at Corso Buenos Aires 24, Milan, Italy. GENNARO MASSI'S present location is unknown. On 6/10/63 Apartment 19, Viale delle Provincie 116, Rome, was leased to one NICOLA MANGANIELLO, who still occupies it. In August, 1963, MANGANIELLO had a new phone number assigned to him, #420.524, which he still has. The user of phone #426.312 is FLORO PICCARI, who is a designer employed in the Fifth Section Technical Office of Verano, City of Rome, Italy. PICCARI was born to MATTIA PICCARI and ANNA DUCHI on 5/17/15 at Sassocorvaro, Pesaro, Italy. PICCARI presently resides at Via Pontedera 5, Rome. PICCARI advised that he has resided at Via Pontedera 5. Rome, since 2/1/64, having come from Via dei Frassini 120, Rome, where he was assigned phone #212.513. When PICCARI moved from Via dei Frassini 120 to Via Pontedera 5, he requested the transfer of his telephone and at that time he was assigned the #426.312, which he still has.

MOSCIANO S. ANGELO (page 29, phone #869.122). This phone number is assigned to the well known U. S. citizen PASQUALE MASSI, born 11/7/03 (see Bufile 92-6590, PASQUALE A. MASSI, aka, AR).

The INP advised that they had been unable to further identify the individuals to whom the telephone numbers set out in referenced Philadelphia airtel pertain inasmuch as the names of the cities in which these telephone numbers are assigned are missing. (u)

It is noted that in the xerox copies of slips of paper found among BRUNO'S possessions, which were furnished to Rome Office by referenced Bureau letter, was the following information:
