burgh airtel to Philadelphia, 10/24/58.

Based on information set out in reairtel 10/29/58,
investigation was conducted in Franklin, Fulton, and Adams
Counties in effort to locate and identify the "hunting lodge"
of the subject.

As a matter of information from personal knowledge
of SA RICHARD H. GRABHAM, RA at Chambersburg, Pa., the in-
formation furnished by the informant that this hunting lodge
is believed to be located within a fifteen minute drive of
Hagerstown, Md., does not coincide with the description of the
land as being within a densely wooded area. Traveling by
automobile from Hagerstown to the following named hunting
areas in Pennsylvania, which will be later mentioned, would
approximate the following time allowing for average speed:

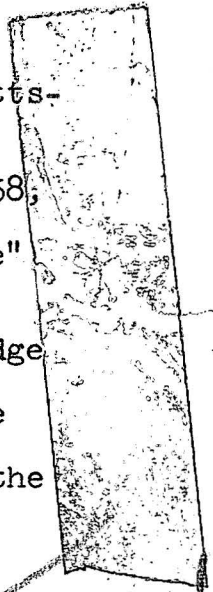
