On 8/13/70 Mr. R. LLOYD WILLIAMS, Sotheby's Co., Auctioneers, advised that to date he has been unable to locate any record of subject having placed goods with his company for sale. He is, however, having additional records checked and hopes to be able to furnish some information in the near future.

For the information of the Bureau and Miami, Sotheby's is one of the leading auctioneers in England dealing in fine art and is a highly reputable company.

There is no record of subject having visited England in the files of the Aliens Arrival and Departure Records; however, the fact that subject is a fugitive and currently wanted by the Bureau has been made known to New Scotland Yard and subject's name has been placed in New Scotland Yard's Fugitive Index.
