Prior to the establishment of this office in December, 1970, fugitive and Selective Service leads for Israel were handled by the Post Security Officer (PSO), U. S. Embassy, Tel Aviv, at the request of the Regional Security Officer (RSO) in Athens, Greece; the RSO acted on instructions from the State Department in Washington, D. C. The PSO thereupon instructed a local employee of the Consular Section, U. S. Embassy, Tel Aviv, to obtain the desired information, generally consisting of verification of an individual's residence in Israel. The local employee maintained a record of his efforts to obtain the verification < for future use, and a review of those records by this office reveals background information regarding captioned individual, in addition to the above-referenced LHM. It is not known if captioned subject is still a fugitive.

The referenced LFM described subject as a white, male, born 6/22/17, in Amarillo, Texas, 5'11", 175 pounds, medium build, salt and pepper hair, blue eyes, fair complexion and he generally wears a mustache.

Efforts to locate information with regard to subject's whereabouts by the local employee of the Consular Section in September, 1970, were without success.

Tel Aviv indices contain no record for the subject.
