C. ASSOCIATES

On December 6, 1972, PG T-1 advised:

With regard to the story that some guy named MARIO from East Liberty, Pittsburgh, wanted a guy named SCORATOW "taken care of" and was offering a lot of money, on December 5, 1972, informant asked KELLY MANNARINO what his feelings were about the situation.

MANNARINO said the guy who was supposed to be the victim is SID SCORATOW. He said he considered SID SCORATOW to be a "creep," and he could not care less what happened. He said that his brother, MARCO SCORATOW, was a friend of his, and if the contract had been put out on MARCO, he would have ordered that somebody take MARIO's money and then reverse the contract on him. However, he said under the current situation he did not care which way the thing was handled, so long as it did not bring any heat on him or his town, New Kensington, Pa.

On December 10, 1972, PG T-1 advised:

EDDIE KLEIN told him that he knew that the young guy, TONY MURGIE, had set him up for the recent armed robbery at KLEIN's residence in Pittsburgh. KLEIN admitted that the figures concerning the cash and jewelry were inflated, but claimed he did not give out the figures that high. He says he is now worried that the Internal Revenue Service will cause him trouble. He had no insurance on the stolen property.

KLEIN said he was worried as he wondered if "the mob" knew of, and approved, this heist, since the young man, TONY MURGIE, is a nephew of CHARLIE MURGIE of the Youngstown, Ohio, area. He pointed out that most of the "good stuff" which had been taken was given to him for disposal by PAUL HANKISH of Wheeling, W. Va., and he felt HANKISH might be angered.

HANKISH, when told of the situation, agreed that they would have to go through "mob" connections to get the stuff
