INFORMATION CONCERNING

The following is being brought to the attention of the Bureau regarding the head of the Pittsburgh Strike Force (PSF), MILTON J. CARP:

On 2/11/74, MILTON CARP advised SA T. A. MEEK, JR., Pittsburgh Office, that he had just completed a review of a 92 report concerning GABRIEL MANNARINO, known LCN member, Pittsburgh Division, and had come across the name CALDERWOOD. CARP advised that he was acquainted with Mrs. CALDERWOOD, whose maiden name was LANZINO, and that her uncle was involved in the operation of the Bachelors Club in New Kensington, Pa. It should be noted that LANZINO is the subject of Pittsburgh file 92-1645 and is GABRIEL MANNARINO's right-hand man in the administration of this casino. CARP advised SA MEEK that if Mrs. CALDERWOOD's telephone toll records had been subpoenaed, his telephone number would probably appear thereon. SA MEEK advised that CARP met Mrs. CALDERWOOD approximately three weeks prior to that time at a party and that he left the party in the company of Mrs. CALDERWOOD.

On 3/12/74, PG 961-C, an informant who has furnished information known to be extremely reliable in the past advised that MILTON CARP is presently dating a "hooker" named LORRAINE SILVERSTEIN and has taken SILVERSTEIN to several dinner parties. SILVERSTEIN, FBI #369 296 G, has been arrested on numerous occasions for sodomy, prostitution and conspiracy.
