Re Bureau letter 1/15/68.

(S) In accordance with Bureau instructions relating to the
AHC establishing personal contact with SUE FRANK, Chicago proposes
that CG 6328(S) and CG 5851(S) travel to New York City during the
third week of July for the two-fold purpose of contacting FRANK
and the Albanian Mission to the United Nations. (S)

The contact of FRANK will be made without reference to
FRANK's association with or break from PLP nor to her allegedly
having a channel to China. Instead, conversation will be initiated
by CG 5851(S) stating that prior to his death CG 5908(S) confided to
him that he intended to see FRANK because "several of the people
I saw in Europe recommended I talk to her." CG 5851(S) will
disclaim knowledge of any other particulars as to the intentions
of CG 5908(S) in regard to FRANK other than to indicate that the
AHC knows of FRANK's being pro-Chinese and a former CP member.
The AHC legend will be furnished FRANK and CG 6328(S) will describe
the Committee's work with Black Power groups and other fictionalized
mass activity. (S)

If informant's detect a need to be specific as to the
reason for contacting FRANK she will be told that they are in
New York to evaluate conditions regarding reactivating the New
York chapter (of Ad Hoc) (S). No names will be mentioned but allusion (S)

will be made to a [(fictionalized)] CP member on the New York State Committee who precipitously contacted [the AHC] before defecting from the CP and was persuaded to delay an open break while a study is made of forming [an AHC] chapter around him. FRANK will be asked if she believes conditions in New York are ripe for such a group (S)

Obviously the contact cannot be pre-planned much beyond the above, with informants instructed to "play it by ear", leaving the door open for further discussions and making no commitments on behalf of [the Committee]. (S)

The comments of the New York Office are requested together with all pertinent up-to-date information concerning FRANK which could have a bearing on the tactics of the approach, including any information as to whether she will be in New York City during this period. (S)(u)

Concerning the contact with [the Albanian Mission], CG [6328]-S will introduce CG [5851]-S as the successor to CG [5908]-S in some areas of [Committee] work and the source of some of the CP material which has been forwarded to [the Albanians]. (S)

Informants will explain their mission primarily as being to present a formal request to [the Mission from the AHC] asking that [Albania] introduce [a resolution in the United Nations] calling for world support for the liberation struggle for the Afro-American people (S)

Informants could also contact NY 1656-S, in accordance with Bureau letter 6/17/68, while in New York. Such contact would be in response to the New York informant's having written [the AHC] in the interim. (S)

New York Office is requested to comment on this proposal as to informant's availability for such contact as well as to whether he can be briefed under suitable pretext to direct the aforementioned letter to [the Committee] in the next few weeks. (S)

Bureau authority is requested to implement the above plan pending comments of the New York Office. (u)
