In response to Bureau's instructions, the New York Office in reNYairtel submitted the text of a letter to be sent to T'ANG Ming-chao, Vice-Chairman, Chinese People's Committee on World Peace, Peking, China.

Legat is requested to prepare a type\_written letter to T'ANG on stationery purchased in Canada and utilizing the text suggested by the New York Office. It will not be necessary to utilize the apostrophe in writing T'ANG's surname or the Bureau approved manner of writing Chinese names, for to do so would indicate a knowledge of the Chinese language on the part of the writer which might not be the case. It is suggested that the name be written in the following manner: Tang Ming Chao.

Legat should also advise RCMP on a confidential basis of the details of this operation. and obtain its concurrence prior to sending out the letter described above.

Susan Frank is known to have wide spread contacts with whom she has discussed recent reports of a purge of her Caucasian friends in Peking who are working there for the Chicoms. She has left the U.S. on a trip to Paris and London to verify these reports. X We are attempting to exploit this situation by having an anonymous letter written by a person in Canada, who proportedly was a member of a Canadian's) left wing group which visited China in 1966. The letter would be addressed to the individual who greeted the group when it visited Peking and who is believed to be identical with a close contact of Susan Frank. The letter would point out the concern of the writer and the subject over the aforementioned purge. Primary objective of this operation is to shake the confidence of the Chinese in Susan Frank. New York has submitted the text of the letter to be used and it is being furnished to Legat, Ottawa, to be typed and sent to China. [Legat, Ottawa, is also being instructed to advise the RCMP concerning this operation. The

(s) "I was one of the fortunate group of individuals from Canada who were afforded the privilege of visiting your country in October, 1966.

"Perhaps you will not remember me, but I had the pleasure of meeting you in Peking during our visit when you and other members of the Chinese People's Government greeted and allowed us the opportunity to present questions regarding your country.

"At that time, I expressed some concern at, what appeared to be, excesses of the Cultural Revolution and wondered whether some of the people who had suffered violence and abuse at the hands of the Red Guards might not in fact be innocent. Your reply was that as a result of over enthusiasm it was always possible to make mistakes, however, they would be rectarfield in time. (a)

"My purpose in writing is to express my concern and that conveyed to me by a friend from NY, SUE, a loyal Maoist, and acquaintance of yours, over the fact that recent reports have indicated that long time friends of the Chinese People's Government, ISRAEL EPSTEIN and his wife and MICHAEL SHAPIRO had been arrested for espionage; SIDNEY RITTENBERG had been purged from his job with Radio Peking and ANNA LOUISE STRONG had been condemned as an "imperialist agent." We are deeply concerned regarding the treatment of these friends of the Chinese People's Government and wonder whether the abuses which I previously mentioned are continuing in spite of your statement the mistakes would be rectified. If these rumors are true as serious mistake has been made and we appeal to you as a friend to intercede on behalf of the friends of the Chinese People's Government.

"You can well understand my reason for not signing the letter or identifying SUE, for to do so could conceivably disclose our identities to the authorities. (K)(U)
