Re New York airtels and LHMs 7/1/68 and 7/23/68,  
and Bureau letter to London 8/1/68, enclosing New York airtel  
and LHM 7/26/68.

On 7/16/68 and on 7/31/68, referenced New York LHMs  
dated 7/1/68 and 7/23/68 were furnished to the Direction de la  
Surveillance du Territoire (DST), French domestic counter-  
espionage service, and the Service de Documentation Exterieur  
et de Contre-Espionnage (SDECE), French foreign intelligence  
and counterespionage service, Paris, alerting them regarding  
subject's arrival and requesting any information they are  
able to obtain regarding her activities while in France. (S)

Upon receipt of referenced Bureau letter, [our French  
sources were requested on 8/6/68 to afford subject maximum  
coverage possible.] (S)

The Bureau and New York will be promptly advised of  
the results of this coverage. Our French sources hopefully  
expect to be able to identify some of subject's contacts while  
in Paris. (S)
