The Las Vegas Office advised that ROSSELLI was observed by Special Agents of that Office in the Casino and Coffee Shop of the Desert Inn Hotel on the evening of 10/16/63. On 10/28/63 LA 4145-C advised that he attended the Western States Tavern Show at the Convention Center in Las Vegas, Nevada, on 10/15,16, and 17/63, where a number of companies displayed refrigeration and ice making machines. Informant said that he saw ROSSELLI at this Convention on 10/16/63. Informant was advised by a representative of AJAX West Coast Corporation, Santa Barbara, California, that as a result of the convention ROSSELLI sold 32 Kold-Draft ice cube machines to hotels in Las Vegas. LA 4145-C said that ROSSELLI's profit on each machine would be at least \$1,000. Informant further stated that when ROSSELLI was at the convention on 10/16/63 he was accompanied by representatives of the Tropicana and the Desert Inn Hotels and that he believes that the representative from the Desert Inn was RUBY KOLOD.
