LA 4396-C\* has furnished no information indicating that ROSELLI has been residing at his Los Angeles apartment during the past ten days.

LA 4393-C on 11/24/63 advised that on one or more occasions during the previous week, ROSELLI spent the night at the residence of DINA STEPHENS in Beverly Hills, California. It is recalled that STEPHENS is one of the two girls who went with ROSELLI and MAURICE H. FRIEDMAN to Phoenix, Arizona, on 11/26/63.

LA 4268-C advised that he was at the Friar's Club, Beverly Hills, California, on 11/28/63 and 11/29/63 but did not see ROSELLI there.

On 12/2/63, PCI [redacted] advised that on 11/20/63 JUDITH CAMPBELL (friend of ROSELLI and of SAM GIANCANA of Chicago) called the Beverly Crest Hotel, Beverly Hills, California, and stated that MORRIE FRIEDMAN of the New Frontier Hotel told her the Beverly Crest Hotel would make a room available to her; that the hotel did rent her a room which she occupied until 11/27/63 when she said she was going to Las Vegas for the week end; that ROSELLI visited her at the hotel on 11/20/63; and that on the 27th, the day she left the
