On 3/10/64 JAMES P. CANTILLON, ROSSELLI's attorney, called SA HAROLD F. DODGE and advised that he wanted to report that ROSSELLI had moved from his old apartment; that he had rented an apartment in Glen Towers, 1333 South Beverly Glen Boulevard, but had not yet moved in because the apartment was being decorated. CANTILLON said he does not know where ROSSELLI is residing in the meantime but he imagines he would be at the Desert Inn Hotel in Las Vegas, Nevada. CANTILLON said it is his impression that ROSSELLI's rent for the new apartment is about \$600.00 per month.

On 3/6/64 MM 830-C advised the Miami Office that there was no registration for ROSSELLI at the Fountainebleau Hotel, Miami Beach, Florida and that VICKIE LOCKWOOD checked into room #662 on 2/25/64 alone, giving her address as 10 Park Avenue, New York City. At the time of registration she listed her departure date as 3/1/64 but was still there on 3/6/64.

On 3/11/64 LA 4448-C-TE advised that on 3/10/64 he met HY GOLDBAUM at Santa Anita Race Track and GOLDBAUM remarked that he had spent several days during the previous week at the Cottage Hospital in Santa Barbara and that JOHN ROSELLI was also in the hospital for a few days the same week for a physical check up.

On 3/11/64 information was received from the Los Angeles Police Department, Intelligence Division, that MAURICE H. FRIEDMAN, part-owner of Hotel Last Frontier Corp.,
