Re your request for photographs and fingerprints of those individuals charged as defendants and co-conspirators in captioned case for transmittal to RCMP Headquarters, Identification Branch. (v)

The following individuals were indicted in the Southern District of New York on May 13, 1959, and charged with conspiracy to commit perjury and obstruct justice from November 14, 1937 to the date of the indictment. The FBI number accompanies the name of each individual. It is to be further noted that the identification record of each of these individuals with the exception of Salvatore Falcone, Joseph Ida, James V. LaDuca, Antonio Magaddino, and Michele Miranda reflect an arrest in connection with this charge. Falcone, Ida, LaDuca, and Magaddino have never been apprehended on this charge. Although Miranda was arrested on this charge, no fingerprint record of this arrest was received by the Bureau. The record of each of the aforementioned five individuals are therefore stamped as possibly identical with the subject of the indictment.
