WEEKLY SUMMARY AIRTEL

CG 6343-C* reported on 11/16/60 that MURRAY HUMPHREYS, GUS ALEX, FRANK FERRARO, ANTHONY ACCARDO and GIANCANA were to have a meeting at the St. Clair Hotel, Chicago, on 11/18/60. HY GODFREY was dispatched to the St. Clair to make the necessary arrangements for a suite. 4 Illinois

On 11/18/60, a physical surveillance at the St. Clair Hotel disclosed that HY GODFREY was observed at 10:30 a.m. conversing with DAVE GARDNER, his contact at this hotel. At 11:35 a.m., SAM GIANCANA, accompanied by RALPH PIERCE, entered the St. Clair and proceeded to the 12th floor. On the same date, CG 6343-C* reported that "they" had Room 12-E reserved. 4

On 11/16/60 and 11/17/60, PCI GLADYS EBLE advised that GIANCANA and ROCCO POTENZO were, on those dates, at the Armory Lounge, Forest Park, Illinois. 4

On 11/17/60, LOIS STEVENS advised that she had been acquainted with GIANCANA during 1959, and had met with him on several occasions at the North Avenue Steak House, Maywood, Illinois, which she assumed was owned by GIANCANA. 4

On 11/15/60, a physical surveillance at Pete Fish's Restaurant, 161 E. Ontario, Chicago, disclosed the presence of ANTHONY ACCARDO, JACK CERONE, FRANK FERRARO and RALPH PIERCE. On 11/16/60, CG 6343-C* reported that in addition to the above persons at Pete Fish's for a luncheon conference on 11/15/60 were GUS ALEX and SAM GIANCANA. 4 92-3171-86
