CG 6379-C advised on 11/22/60 that he has been propositioned recently by CHARLES NICOLETTI and WILLIAM "POTATOES" DADDANO to perform some unknown errands in the Forest Park, Illinois, area, on Monday night. DADDANO and NICOLETTI are close associates and lieutenants of GIANCANA. The possibility exists that CG 6379-C may act as a courier as his assignment. This matter is being closely followed. (4)
