JUNTA REVOLUCIONARIA CONSTITUCIONAL POREIGN POLITICAL MATTER

Re Miami tel May 19 last which transmitted information furnished by this office to the effect that information had been received indicating that there might be some trouble on May 20, 1952, this being the 50th Anniversary of the Cuban Republic.

This is to advise that May 20 passed without incident. A large military parade was held and BATISTA was present. No effort was made to molest BATISTA.

[`]Mr. JOHN BONDS of the INS office here advised on 5-21-52 that he had received information from Mr. PILCHER of the Border Patrol in Miami that AURELIANO SANCHEZ WARANGO is definitely in Santiago, Cuba. Mr. PILCHER claimed that this information came from a source whom he considers completely reliable. It is believed that this information is most likely correct in that Cuban investigating authorities, although they have not been able to find SANCHEZ ARANGO, are still receiving information that he is in Cuba.

Contact is being maintained with all available sources although this office is conducting no active investigation in this matter. It will be recalled that original information received from the Cuban Army indicated that the revolutionary plan was to be put into effect on the night of May 31-June 1, 1952. It is believed that should Cuban authorities be successful in locating SANCHEZ ARANGO prior to that date, there is small likelihood that any counter revolution will be started.
