LA 4396-C* furnished information that ROSSELLI has been residing at his Los Angeles apartment April 10, 11 and 12, 1963. On 4/11/63 this informant stated that it appears that JOSEPH I. BREEN, JR., close friend of ROSSELLI, may have accepted employment in a public relations capacity with a bank in Las Vegas. Source indicated that ROSSELLI had assisted BREEN in obtaining this position. The name "HOLLY" was mentioned and this may refer to HARLEY E. HARMON who owns an insurance business and bank in Las Vegas and who in the past has been mentioned by LA 4396-C* as a possible employer of BREEN.

LA 4268-C advised that ROSSELLI and MAURICE H. FRIEDMAN, part owner of the New Frontier Hotel in Las Vegas, were at the Friar's Club, Beverly Hills, California, during the afternoons of April 10 and 11, 1963. FRIEDMAN checked out of the Beverly Crest Hotel on 4/11/63 and presumably returned to Las Vegas.

On the evening of 4/11/63 ROSSELLI picked up a girl at the Grosvenor Apartments in Beverly Hills, California and went to dinner at a restaurant located in Kirkeby Towers, Westwood Village, Los Angeles, California. ROSSELLI picked up a girl at the same apartment building on 4/4/63. This girl may be LORRAINE ALLEN, aka Stalford.
