ROSSELLI returned to Los Angeles on 4/23/63 after having been away since 4/17/63. His whereabouts during this period not presently known.

On 4/24/63, LA 4396-C* furnished information that ROSSELLI plans to travel to Las Vegas this weekend and will return to Los Angeles after the golf tournament which will take place May 3, 4, & 5, 1963.

LA 4268-C advised ROSSELLI at Friar's Club, Beverly Hills, on April 24, 25, & 26, 1963. On 4/24/63, ROSSELLI had conferences at Friar's Club with JOSEPH I. BREEN, JR. and man named "LOU" who, from description and first name may have been LOUIS J. LEDERER, close friend of ROSSELLI of Chicago, Illinois. BREEN, ROSSELLI, "LOU", & MORRIE SUESS, motion picture director, discussed a trip to Tokyo and Hong Kong, but informant unable to obtain specific details.
