## MM 92-139 Sub II

Referenced New York airtel suggests RUSSELL, referred to on page 31, may be RUSSELL BROWN, of Coral Gables, Florida; however, it is felt that RUSSELL, mentioned in referenced Philadelphia airtel, is in reference to DAVID ALLEN RUSSELL, FAC who is MM 926-PC. RUSSELL is a Miami attorney who has been in CONF. INF. Contact with BRUNO and SANTO TRAFFICANTE and, according to his own estimation, is the leading authority on the preparation of casino contracts.

> On 5/7/64, MM 926-PC, mentioned above, advised that he had previously received unconfirmed information to the effectthat ANGELO BRUNO had an interest in the Coney Island Amusement -Park at Santo Domingo, Dominican Republic, which Park is reportedly owned by BERNARD "BUCKY" ALLEN, who has a home in Miami .-Informant said that there are at present a few old and obsolete slot machines on location at this Amusement Park. With regard to BRUNO, informant stated that he has heard that BRUNO may have approximately 400 slot machines stored somewhere in the Dominican Republic. Informant also added that he has not been able to a series of the series of ascertain the location of these machines, nor has he been able to verify their existence in the Dominican Republic. This informant advised that he is definitely in a position to learn of any negotiations for the operation of any gambling casinos or large gambling operations in the Dominican Republic. Informant is quite sure that neither ANGELO BRUNO, nor anyone who is a well known hoodlum, is engaged in any current negotiations for any new gambling operations in the Dominican Republic. He advised that he would bring any new information coming to his attention or developed by himself relative to the involvement of ANGELO BRUNO in the Dominican Republic to the attention of the FBI.

To date, MM 926-PC has not developed any additional information in regard to the foregoing.
