SOURCE MET WITH FRANK MONTE, SOLDATO PHILADELPHIA FAMILY LA COSA NOSTRA. MONTE CONFIRMED HIS MEMBERSHIP IN COSA NOSTRA AND ASSIGNMENT TO DECINA HEADED BY PHILIP TESTA. MONTE STATED THAT HE RECIEVES ONE HUNDRED DOLLARS WEEKLY FOR HANDLING PORTION OF BRUNO'S NUMBERS LOTTERY ACTIVITY. MONTE CONFIRMED JOHN SIMONE, TRENTON N.J. IS CAPODECINA FOR THAT AREA OF PHILADELPHIA FAMILY.

MONTE DISCUSSED POSSIBILITY OF PERFORMING ARMED ROBBERY WITH SOURCE AT UNDETERMINED DATE IN FUTURE WHICH WOULD NET EACH PARTICIPANT APPROXIMATELY FIVE THOUSAND DOLLARS.

IN BRUNO ITAR TRIAL HIS ATTORNEY THOMAS MC BRIDE, ACCORDING TO SOURCE, IS CONSIDERING POSSIBILITY OF SUPOENAING BRUNO'S U.S. PASSPORT AND RECORDS OF ITALIAN TRANSPORTATION LINE USED BY BRUNO IN HIS NINETEEN SIXTYTHREE TRIP TO ITALY. ATTORNEY'S PURPOSE WILL BE TO SHOW BRUNO WAS ABSENT FROM U.S. DURING MAJOR PORTION OF TIME REPAYMENT OF VICTIM'S LOANS WERE BEING NEGOTIATED.

PETER MAGGIO, SOLDATO PHILADELPHIA FAMILY AND BROTHER-IN-LAW OF BRUNO WAS ACTIVE IN COURTHOUSE THIS DATE ON BEHALF OF BRUNO IN ATTEMPTING TO OBTAIN BACKGROUND OF JURY MEMBERS FROM REPORTERS OF PHILA. NEWSPAPERS. MAGGIO'S PLANS ARE NOT KNOWN AS YET.
