JUDITH LOPINSON AT DANTE'S RESTURANT JUNE NINETEEN LAST SOURCE ADVISED

AS FOLLOWS: STORIES CIRCULATING AMONG PHILADELPHIA RACKETS

PERSONALITIES TEND TO ABSOLVE ~~FRANK NARDUCCI~~ ^{Pa}, COSA NOSTRA MEMBER, OF

ANY PART IN KILLINGS. SOURCE STATED THAT BRUNO IS KNOWN TO HAVE DINED

AT RESTURANT DAY BEFORⁿ THE KILLINGS AND THIS FACT IS BEING TAKEN

AS SIGN THAT THERE WAS NO BAD FAITH BETWEEN BRUNO, NARDUCCI, AND

MALITO AS A RESULT OF NARDUCCI'S QUARREL WITH MALITO.

SOURCE ADVISED THAT ~~JACK LOPINSON~~ ^{Mr. J. L.} HUSBAND OF VICTIM JUDITH ^{deceased}

~~LOPINSON~~ IS SUSPECTED IN RACKET CIRCLES OF HAVING SHOT MALITO, HIS

OWN WIFE, AND THEN WOUNDING SELF WITH GUN SHOT WOUND IN LEG. SOURCE

STATED THAT POLICE BALISTICS HAVE RULED OUT POSSIBILITY THAT GUN

FOUND IN JACK LOPINSON'S POSSESSION SHORTLY AFTER THE KILLINGS WAS THE

MURDER WEAPON. POLICE ALSO CHECKED THIRTEEN OTHER GUNS FOUND IN JACK

LOPINSON'S HOME AND ARE SATISFIED THEY WERE NOT MURDER

WEAPONS. SOURCE WHO WAS PERSONALLY ACQUAINTED WITH MALITO, AND BOTH

LOPINSONS STATES THAT JACK LOPINSON HAD AT LEAST TWENTY REVOLVERS IN

18 JUN 25 1964

HIS GUN COLLECTION, AND OBVIOUSLY HAS NOT TURNED ALL OF THEM OVER TO

PD FOR BALLISTICS TEST.
