At airport he exhibited Italian Passport #541830 issued to Antonio, Esposito, born Naples, Italy, 6-18-11. Passport issued 7-3-62 by Italian Consulate at Frankfort, Germany. (4-1.) (4) "Police Passport Control Officers recognized Bruno and recognized passport as being false. Italian Police have seized passport. So far as is known he does not have U.S. Passport with him. Travel times following not verified, but apparently Bruno left from Edmonton, Canada, on Canadian Pacific Airlines, flight #382, on 7-30-64 en route to Amsterdam. He arrived Amsterdam 10:15 a.m. on 7-31-64 and proceeded to Milan by (air arriving sometime afternoon of 7-31-64. Since Bruno was bearing falsified passport he was not permitted to enter Italy and is being placed aboard KLM, flight #342, leaving Milan for Amsterdam at 2:25 p.m. today, 8-1-64. (G-1)/u/ "Since he is not known to have other passport, Dutch authorities will probably place him aboard plane to take him back to Canada from where he came.
