Re Legat, Ottawa, airtel 8/4/64 captioned  
"Angelo Frank Bruno, aka, FPC."

Reairtel refers to travel of an individual who was believed to be the subject and who had arrived in Italy in the afternoon of 7/31/64, that Italian authorities refused to accept him, and he was returned to Amsterdam on 8/1/64. Further, that Italian authorities had later reported to Canadian immigration officials that this individual was identical with Angelo Bruno Annalora, aka Angelo Bruno, subject of this case. (G-1)(u)

For your information, Angelo Bruno, FBI number 1045098, head of the Philadelphia family of La Cosa Nostra, checked out of a New York hotel on the afternoon of 7/31/64 to return to Philadelphia. Highly confidential sources reported that Bruno was in Philadelphia on 8/3/64. He and his wife, Sue, departed Philadelphia on the night of 8/3/64 for Miami, Florida. They returned to Philadelphia in the early morning of 8/7/64 where they have been since that date.

In view of the above, Angelo Bruno, FBI number 1045098, could not be identical with the individual who, according to information received by Bureau from Legat, Rome, arrived in Milan, Italy, on 7/31/64 on a flight from Edmonton, Canada, via Amsterdam, Netherlands, and who exhibited to authorities a falsified Italian passport number 541830 issued to Antonio Esposito, born in Naples, Italy, on 6/18/11. He was excluded from Italy and ordered to Amsterdam for probable return to Canada by Dutch authorities in view of his use of the falsified passport. This individual may have been identical with Angelo Frank Bruno, FBI number 5677. (G-1)(u)

Legats in Rome and Bonn were advised on 8/1/64 that Esposito was possibly identical with Angelo Frank Bruno, FBI number 5677. Legats, Rome and Bonn, are in possession of all pertinent information regarding this matter. Copies of Identification records and fingerprints for both subjects were forwarded to Legat, Bonn, on latter's request. [Legat, Ottawa, may wish to discuss this matter further with Canadian immigration officials in order to acquaint them with these facts.] (G-1)(u)

NOTE: This relates to the travel of an Italian national, Angelo Frank Bruno, to Italy on 7/31/64 following his exclusion from Canada. He used a falsified passport in the name Antonio Esposito upon his arrival in Italy and as a result was excluded from Italy and ordered to return to Amsterdam. Italian authorities believed this individual was identical with Philadelphia hoodlum Angelo Bruno, who plans to leave on a European vacation trip in August, 1964. Legat, Ottawa, requested information regarding Philadelphia Bruno's whereabouts during the pertinent period since Italian authorities had notified Canadian immigration that Philadelphia Bruno had made the trip to Italy and was excluded. Reference is made to Ottawa telephone call to the Bureau (Mr. Staffeld of Criminal Intelligence Division) on July 28, 1964, requesting photograph, Identification Record and fingerprints for captioned individual who had been arrested by Canadian Immigration in western Canada and was being held for deportation to Italy. This material was received 7/30/64, and furnished to Mr. Darcy Murphy, Canadian Immigration, who advised at that time that BRUNO had admitted his true identity and had been ordered deported and was flown to Italy via Amsterdam the same date. (S-1)(u)

On instant date Mr. Murphy advised that when subject arrived in Italy, the Italian authorities refused to accept him and he was returned to Amsterdam. Italian authorities said he was ANGELO BRUNO ANNALORA, aka Angelo Bruno, a naturalized U. S. citizen from the Philadelphia area and named as a member of the Mafia by VALACHI. (S-1)(u)

Mr. Murphy requested that the Bureau furnish the current whereabouts (especially during the past two weeks) of ANGELO BRUNO ANNALORA so that Italian authorities may be so advised. (S-1)(u)
