Referenced letter furnished details of subjects' arrival in the United Kingdom on September 30, 1959, from Paris and their departure to Paris on October 4, 1959. Mylet also stated that British Security Service MI-5 had been alerted regarding the presence of these subjects in the United Kingdom and checks would be made with MI-5 to determine if any security information concerning them was obtained. (S)

[On October 19, 1959, Mr. JACK A. CRADOCK, British Security Service MI-5, advised that no security information was developed concerning subjects while they were in the United Kingdom and as far as he was able to determine their presence here was purely for sightseeing and touring.] Inasmuch as the subjects have departed the United Kingdom and did not come to security notice these cases are being placed in an RUC status. (S)
