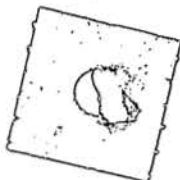

BRUNO'S WHEREABOUTS STILL UNKNOWN.

PH 614-C-TE AT ATLANTIC CITY SUNDAY, AUGUST 18 LAST, REPORTS OWNER MONACO MOTEL, BRUNO'S USUAL STOPPING PLACE, CLAIMED NO KNOWLEDGE RE BRUNO'S WHEREABOUTS. PETER MAGGIO, BROTHER-IN-LAW, MOST LIKELY TO KNOW BRUNO'S LOCATION, MAKING CONFLICTING STATEMENTS. MAGGIO INDICATED AUGUST 19 TO PH 269-C BRUNO RETURNING PHILA ABOUT AUGUST 25. MAGGIO ALSO INDICATED TO SAME SOURCE HE HAD BEEN ATLANTIC CITY OVER PAST WEEKEND. PCI [ ] REPORTED AUGUST 19 PETER MAGGIO VISITED BROTHER MARIO AT VENTNOR, NEW JERSEY, OVER PAST WEEKEND.

MAGGIO TOLD PH 614-C-TE AUGUST 19 HE HAD SPENT QUIET WEEKEND AT HOME AND WOULD WAIT UNTIL BRUNO'S RETURN ON UNNAMED DATE BEFORE RESOLVING PROBLEM OF SIGNATURE CARDS FOR PENN JERSEY VENDING ACCOUNT.

PH 591-C\* REPORTED AUGUST 19 MAGGIO TOLD ANTONIO POLLINA BRUNO DID NOT TELL HIM WHERE HE WAS GOING, NOR DID HE INQUIRE.

PH 571-C\* REPORTED AUGUST 19 BRUNO TOLD WEISBERG, "I DON'T HAVE TO TELL YOU I'LL BE GONE AND IF YOU WANT ME YOU KNOW WHO TO WIRE."
