Re Philadelphia teletype 8-26-63.

Retel reports that PH 614-C-TE on 8-26-63 advised that Ben Golub, close business associate of Bruno, had traveled to Washington, D. C., on 8-24-63 to keep an appointment with an individual who is presumably Bobby Baker, who is employed on the staff of Senator Mike Mansfield. Informant further advised Baker was allegedly arranging a loan up to \$350,000 on Golub's behalf from the "Small Loans Administration" for the purchase of "Continental Vending Machine."

Philadelphia requested to follow this matter closely with PH 614-C-TE for the purpose of developing additional details concerning this alleged loan. After reasonable time period has elapsed so as to avoid disclosure of the source, Philadelphia will request the Washington Field Office to determine if a Small Business Administration loan has been made to Golub and to obtain full details. Dissemination to the Small Business Administration at this time concerning Golub's association with Bruno and the latter's interest in anything Golub undertakes should be withheld until additional facts are known.

NOTE: Knowledge that proceeds of Government loans available to hoodlums and their associates would be of considerable interest to the Bureau. Bobby Baker is Secretary of the Senate Majority who has been active with Las Vegas gambling figures in obtaining business interest in the Dominican Republic. Continental Vending is heavily infiltrated hoodlum business organization now undergoing financial difficulties. Small Loans Administration is apparently Small Business Administration, which administers loans of the type described above.

BRUNO IN PHILADELPHIA AS OF 2 PM TODAY. PH 623-C*, AUGUST 22 LAST, ADVISED BEN GOLOB, CLOSE BUSINESS ASSOCIATE OF BRUNO, DEPARTING PHILADELPHIA 8:30 AM, AUGUST 24 ACCOMPANIED BY JOE WILSON FOR VISIT TO WASHINGTON. WILSON, CAMDEN, NEW JERSEY, HAS HANDLED SOME ACCOUNTING WORK AND LEGAL PROBLEMS FOR BRUNO.

PH 614 - C T E, TODAY, RELATED PURPOSE GOLOB VISIT TO WASHINGTON, D.C., WAS TO KEEP APPOINTMENT WITH "BAKER" WHO IS EMPLOYED ON STAFF OF SENATOR MIKE MANSFIELD. GOLOB CLAIMS BAKER ARRANGED FOR HIM DURING VISIT, TO RECEIVE FROM SMALL LOANS ADMINISTRATION A LOAN UP TO \$350,000. PURPOSE OF LOAN ALLEGED TO BE FOR PURCHASE OF "CONTINENTAL VENDING MACHINE," DESCRIBED AS BANKRUPT MANUFACTURER OF CIGARETTE VENDING MACHINES. INFORMANT SAID BRUNO WOULD HAVE INTEREST IN ANYTHING GOLOB UNDERTAKES.

BRUNO TOLD SOURCE RAY COHEN, SECRETARY, LOCAL 107, TEAMSTERS UNION, PHILADELPHIA, "LOOKING FOR MY (BRUNO) HELP IN THE WORST WAY."

SIGNIFICANCE OF THIS NOT EXPLAINED. BUT COHEN, SECRETARY AND HEAD OF LOCAL 107, TEAMSTERS UNION, PHILADELPHIA, KNOWN TO BE LOCKED IN BATTLE WITH EDDIE WALKER, AND OTHER OFFICIALS OF 107 FOR CONTROL OF THIS UNION.

BRUNO ARMED AND DANGEROUS.
