BRUNO IN PHILA OVER WEEKEND SEPTEMBER 14/15. SPENT MOST OF AFTERNOON, SATURDAY, SEPTEMBER 14, AT FRANK DAMIANO'S STORE WITH NUMEROUS ASSOCIATES. AT SAME PLACE AFTERNOON MONDAY SEPTEMBER 16, MET BRIEFLY, PRIVATELY WITH STEVE MELCHIORRE, FORMER DETECTIVE, PHILA PD, PRESENT PHILA COUNTY DETECTIVE.

BRUNO SENT HIS OFFICE MAN TO BRANCH, FIRST PENNSYLVANIA BANKING AND TRUST, SEVENTH AND PORTER, TO CHANGE \$3,000 IN \$50 BILLS TO \$100 BILLS.

BRUNO INQUIRED WHETHER SKINNY (PAUL) D'AMATO BACK FROM LAKE TAHOE. BRUNO MUST SEE HIM. D'AMATO OPERATES FIVE HUNDRED CLUB, ATLANTIC CITY, NEW JERSEY, IS ASSOCIATED WITH FRANK SINATRA IN CAL-NEVA LODGE, LAKE TAHOE, HAS BEEN CHARGED WITH ATTEMPT TO BRIBE AGENTS, NEVADA GAMING COMMISSION.

WHEN TOLD BY PH 614-C-TE THAT BEN GOLOB COMPLAINED RE INABILITY TO SEE BRUNO, AND GOLOB LEFT FOR DOMINICAN REPUBLIC, BRUNO TOLD SOURCE HE WOULD SEE GOLOB WHEN HE GOES "DOWN THERE."

MRS. BURNO TOLD SOURCE SHE MIGHT NOT BE IN PHILA WEEKEND OF SEPTEMBER 21.
