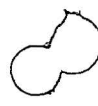

LOS ANGELES 4268-C ADVISED THAT HE APPROACHED ROSELLI AT FRIARS CLUB AUGUST 22 LAST AND ASKED ROSELLI FOR OPINION OF GEORGE SEEDMAN BECAUSE OF ROSELLI'S EXPERIENCE IN DEALING WITH INDIVIDUALS SIMILAR TO SEEDMAN. SEEDMAN RECENTLY TESTIFIED CONCERNING PAYMENT OF \$10,000 TO MICKEY COHEN REGARDING DISPUTE IN VENDING MACHINE BUSINESS. SEEDMAN OFFERED EMPLOYMENT TO INFORMANT. ROSELLI COUNSELED INFORMANT WITH LONG DISSERTATION HOW TO HANDLE SEEDMAN. HE SAID DO NOT SELL YOURSELF - GET A "PIECE" OF CONTRACT AND GET IT IN "WRITING." ASK FOR MORE MONEY WHEN YOU HAVE SOMETHING IN WRITING "THEY CANNOT FREEZE YOU OUT." DO NOT INDICATE THAT YOU ARE NOT AWARE OF SOMETHING - WHEN THEY TELL YOU TO HANDLE SOMETHING - TELL THEM YOU HANDLED IT - WHETHER YOU DID OR NOT. ROSELLI SAID HE LEARNED THIS THROUGH EXPERIENCE IN HIS OWN DEALINGS. HE TOLD INFORMANT TO COME BACK TO HIM IF HE SHOULD RUN INTO SOMETHING AND NOT KNOW HOW TO HANDLE THE SITUATION.
