LA 4268-C ADVISED ROSSELLI AT FRIAR'S CLUB, BEVERLY HILLS, CALIFORNIA AT 6 PM SEPTEMBER 4 LAST WITH IRVING J. LEFF AND MAURICE H. FRIEDMAN, BOTH PART-OWNERS NEW FRONTIER HOTEL, LAS VEGAS, AND JOSEPH I. BREEN, JR., A CLOSE FRIEND. ROSSELLI AND ABOVE PERSONS LEFT CLUB ABOUT 7:30 PM.

LA 4396-C* ADVISED ROSSELLI ENTERTAINED UNKNOWN PROSTITUTE AT HIS APARTMENT LAST NIGHT. HE TOLD HER HE WAS GOING TO COPENHAGEN "TOMORROW" (SEPTEMBER 5, 1962), AT 11 AM AND WOULD BE GONE THREE WEEKS.
