PAST WEEKEND AND ON MORNING OCTOBER EIGHT INSTANT WHEN  
RENTAL CAR FROM HERTZ CORPORATION PARKED IN HIS GARAGE STALL.  
HERTZ CORP. ADVISED ROSSELLI RENTED THIS CAR AT THEIR LA  
INTERNATIONAL AIRPORT OFFICE OCTOBER THREE LAST ABOUT ELEVEN  
A. M. ROSSELLI HAD JUST ARRIVED VIA AIR FROM LAS VEGAS. HE
