A PCI of the Pittsburgh Division who has furnished reliable information regarding La Cosa Nostra (LCN) activities in Pittsburgh and LCN activities in Rhode Island of undetermined reliability advised on 4/3/69, that according to his sources in Rhode Island, JOHN VITALE, described as a heavy, balding individual, has been designated to take the spot on the LCN Commission vacated by VITO GENOVESE. VITALE is possibly identical with JOHN JOSEPH VITALE, OO: St. Louis, described as LCN Chief, St. Louis, Mo. PCI observed a photograph of JOHN JOSEPH VITALE and advised he saw him in the summer of 1966, in Providence, R.I., at a meeting consisting of TONY GIARDANO, RAYMOND PATRIARCA, HENRY TAMELEO, "KILLER DANNY," and RICHARD DE SARRO.

PCI also advised DANNY ROMALDI, aka "KILLER DANNY," Providence, R.I., is taking over for RAYMOND PATRIARCA in Rhode Island, and he represented PATRIARCA at the recent LCN conference in Florida. He also said one of the chief purposes for this conference was to discuss the takeover of hotels and casinos at the Caribbean Island of Anguilla.
