Re San Diego letter to the Bureau dated 3/5/69.

The following information was received from SD 1064-C-TE, regarding La Cosa Nostra (LCN) members and other hoodlums:

I. LOS ANGELES DIVISION

Informant has had several meetings with Los Angeles LCN Boss NICK LICATA. These meetings have occurred on March 6, 1969, March 11, 1969, March 18, 1969 and April 1, 1969. Most of these meetings have occurred at LICATA's apartment with the exception of one meeting which occurred at Du Pars Restaurant in Los Angeles. LICATA has been sick with the flu but has recovered. LICATA indicated he had sold his apartment house but that he owns property in the Indio, California area.
