Enclosed are three mounted newspaper clippings received on 5/29/68, from Dr. BORIS GIULIANO, Flying Squad, Police Headquarters, Palermo, Sicily. They are described as follows:

1. April 30, 1968, edition of "Giornale di Sicilia," a newspaper published in Palermo, Sicily. The article is captioned "Industriali Americani Depongono al Processo per il 'racket della droga.'" (American Industrialists Testify at the Drug Racket Trial).

2. May 9, 1968, edition of "L'Ora," a newspaper published in Palermo, Sicily. The article is captioned "Il Processo della Droga, Consulente della Finanza Americana depone per il boss Santo Sorge." (The Drug Trial - American Financial Consultants Testify for Boss Santo Sorge).

3. May 10, 1968, edition of "Giornale di Sicilia," Palermo, Sicily. The article is captioned "Al Processo della Droga, Intermezzo d'alta Finanza." (The Drug Trial - Interval of High Finance).

These clippings do not add greatly to the information furnished in Rome LHM dated 5/22/68. It is, therefore, being left to the Bureau's discretion whether they should be translated and furnished to the Attorney General's office.
