Informant reported the following regarding those persons whom he knows to be La Cosa Nostra, (LCN), members:

DOMINICK LEA, known to the informant as "Little Dom", from Tampa, now residing in the Miami area. He formerly had strip houses in Tampa and in Broward County, and until recently had a card room on Sunny Isles next to or across the street from the psychedelic parlor on Sunny Isles Boulevard. LEA is a member of the TRAFFICANTE family and handles numbers, bookmaking and strip parlors if and when this is possible.

In addition to LEA, the only other TRAFFICANTE family members known to the informant to be residing in Miami are WILLIE DENTAMORA and TONY RANDAZZO. Informant states that RANDAZZO is the one person in whom TRAFFICANTE has complete confidence and who is always aware of the whereabouts and activities of TRAFFICANTE.

Informant was asked about VINCENT BRUNO, owner of Capra's, and stated that although he is a confidant of TRAFFICANTE, and meets at this restaurant on a regular basis, BRUNO is not considered as an LCN member, but at best would be classes as an "Amici".

Informant stated that "CHINK" FACHIANO is a Capodocine of the GENOVESE Family; however, FACHIANO is not considered to be active in the Miami area. FACHIANO commands a high degree of respect, and is answerable only to PATSY ERRA.

With regard to other persons responsible to ERRA, informant advised that ROCCO PELLIGRINO is a member of the GENOVESE Family as is FRANK PELLICCIO, known to the informant as FRANK HIALEAH. PELLIGRINO is answerable to FRANK HIALEAH, and every Thursday morning without fail, these two meet between 8:00 and 10:00 AM for the purpose of discussing the past week's activities. All of this action, which consists of bookmaking, gambling, shylocking, narcotics and fencing belongs to ERRA.

ERRA took over all of the late MIKE COPPOLA's action, and with this inherited JOE MORRISON. MORRISON has probably the largest bookmaking operation in the country and operates this out of his residence phone, utilizing telephone number 866-0161. Informant states that he handles interstate action and accepts wagers upwards of \$1,000.

ALFRED GEORGE FELICE, known to the informant as FREDDY FRANCO, is "made" in the LCN, although the informant is not aware of the family connection. He feels that it is probably the Philadelphia family, since these people are the ones he normally is in contact with. FELICE is in poor health; however, he remains active in the area and is involved in shylocking and narcotics.

SALVATORE CICCONE, known to the informant as "SAL THE SAILOR" is a highly respected member of the LUCHESE Family LCN and is extremely active in Miami, particularly in the fields of narcotics and shylocking.

Informant states that HENRY RUBINO is a long-time member of the GENOVESE Family and remembers RUBINO

from New York. Informant is not aware of the extent of activity on the part of RUBINO in South Florida, except to recall that RUBINO at one time had ownership of Pumpernik's Restaurant in North Dade County.

JOHN TRONOLONE is known to the informant as a member of the GAMBINO Family, LCN and has been for many years. His field of endeavor is primarily shylocking, coupled with whatever gambling action he can operate.
