On June 10, 1968, Police Headquarters, Italian National Police, Palermo, Sicily, made available the following information:

The trial of VINCENZO MARTINEZ and sixteen other persons charged in Italy with aggravated criminal conspiracy resumed on June 6, 1968. The attorney for one of the defendants, SANTO SORGE, filed a motion requesting that all of the volumes of testimony issued by the McClellan Subcommittee on Investigations be translated into the Italian language. The court approved this motion and another motion that the defendants be granted provisional liberty because at least five months time would be necessary to translate the Subcommittee testimony.

The public prosecutor filed a counter motion declaring that the testimony of the McClellan Subcommittee has already been translated into Italian, is in the hands of Investigating Magistrate ALDO VIGNERI and available for production in court. The court overruled itself and ordered the defendants to remain in custody. The trial will resume on Tuesday, June 11, 1968, when it is believed the public prosecutor will request the court to mete out the maximum penalty of 4 to 6 years imprisonment to the defendants.

As of the June 6 hearing, Professor BELLAVISTA, counsel for VINCENZO MARTINEZ, did not introduce into evidence interrogatories executed by GERALD SHUR of the U. S. Department of Justice.
