#### II. CHICAGO DIVISION.

Informant reported Chicago capo FRANK LA PORTE called him from Chicago during the first week of July to inquire about the outcome of the FRATIANNO prosecution (LA PORTE and some of his hoodlum associates were subpoensed for this trial and took the Fifth Amendment privilege). Informant advised LA PORTE concerning the outcome of the trial and LA PORTE said nothing to indicate he expected to return to the San Diego area in the near future. LA PORTE advised the informant that he would keep in touch with him.

III. SAN FRANCISCO DIVISION.

## 1. ANGELO MARINO.

MARINO called the informant about a week ago and told the informant he has followed San Francisco's Mayor JOE ALIOTO's advice and has declined to give a deposition to the attorney for Life Magazine stating that his health is too poor at this time for such activity.

During this conversation, MARINO told him he has acquired an option on some land in Northern California and that he hopes to use this land to build a cemetery. He stated that his friend, ABE CHAPMAN has a friend in the mortuary business, and explained that there was a great deal of profit in such an operation if the license could be obtained. He asked the informant if he could help him arrange for a Teamster loan. Informant told MARINO that TONY GIORDANO, the St. Louis LCN boss knows Attorney MORRIS SHENKER of St. Louis who would be a key man in getting such a loan approved. He advised MARINO to attempt to get such a loan through this channel.

#### 2. ROBERT TEGAY.

Informant advised that BOB TEGAY of San Francisco called him about two weeks ago and said he was coming down to see him, but has not yet showed up.

### 4. FRANCISCO ISADORE MATRANGA.

Informant stated that FRANK MATRANGA has not yet filed bankruptcy, but it is beginning to look as if he will soon do so. That JOE MATRANGA is about to give up attempting to get his state liquor license reapproved. His Attorney, KETH BYROM (former Chief Investigator for the State Attorney General's Office at Los Angeles), could not represent him as the Attorney General complaint it was a conflict of interest. Accordingly, FRANK MATRANGA will now attempt to get back into the bar business openly and therefore, must file bankruptcy.
