FOR INFO OF NEWARK, REFERENCED TELETYPE INDICATED THAT NY FIVE FIVE NINE THREE C DASH TE ADVISED ON JULY ELEVEN, NINETEEN SIXTY EIGHT THAT A HIGH LEVEL CONFERENCE WAS TO BE HELD THAT DATE AT HOUSE OF CHAN RESTAURANT, FIFTY SECOND STREET AND SEVENTH AVENUE, NYC. ACCORDING TO SOURCE, AMONG OTHERS "FAMILY" HEADS ANGELO BRUNO, JOSEPH COLOMBO AND CARLO GAMBINO WERE TO BE PRESENT. NYO INSTITUTED SURVEILLANCE VERIFIED THE PRESENCE OF THESE INDIVIDUALS, AND IMMEDIATELY DISSEMINATED THIS INFO TO <sup>CRIMINAL INTELLIGENCE BUREAU</sup> CIB, NYCPD, WHO ARRESTED SIX INDIVIDUALS SEATED IN THE RESTAURANT FOR VIOLATION OF NY PENAL CODE, SECTION TWO FOUR ZERO (LOITERING). INITIALLY NYCPD IDENTIFIED THOSE ARRESTED AS ANGELO BRUNO, CARLO GAMBINO, JOSEPH COLOMBO, THOMAS MASOTTO, JOHN SCIMONE AND VICENT ALO.
