Enclosed are five and three copies to the Bureau and Dallas Office respectively, of the Los Angeles report of SA CHARLES M. PAGE dated and captioned as above.

Please be advised that a review of Los Angeles indices reflects no information identifiable with NORMAN ROTHMAN being connected with the City of Hope, or any information connecting ROTHMAN with the Dominican Republic. Indices do contain Legat, Havana letter to the Director, FBI, 3/26/54, captioned "FREDERICK J. TENUTO, was., IO#2313-FUGITIVE - UFAC-MURDER", which indicates that a NORMAN ROTHMAN, operator of the Sans Souci Club in Havana, was a PCI in Havana.

Pittsburgh letter to Director, FBI dated 4/3/57 and captioned "UNSUB: Theft of \$250,000.00 Jewelry from Martin Lehr, Arlington Hotel, Hot Springs, Arkansas, 3/27/57; ITSP - Major Theft (OO: Little Rock), on page 29, mentions a NORMAN ROTHMAN as setting up slot machines in Havana.
