Re report of SA MAURICE F. FARABEE, 9/8/72 at Miami; and New York letters to Miami, 10/26/72 and 11/21/72 (interoffice).

For the information of the Atlanta Division, on 1/7/72 the subject was sentenced to five years in prison by Federal District Judge, Southern District of New York, for illegally transporting in interstate commerce stolen securities. He appealed and his appeal was denied by the U.S. Circuit Court of Appeals, 2nd Circuit, in June, 1972. In July, 1972, he filed a Petition for a Writ of Certiorari with the U.S. Supreme Court (72-148). As of 9/28/72, the Supreme Court had not announced a decision on the subject's petition.

On 10/31/72 MM 1401-C-TE informed that subject is incarcerated at the Federal Penitentiary, Atlanta, Georgia.
