DAILY SUMMARY

Reference is made to daily summaries 5/19 and 22/61 pertaining to interviews with CHARLES ENGLISH and DOMINICK "BUTCH" BLASI. CG 6457-PC advised that she was contacted by BLASI 5/19/61 and by prearrangement with this office, advised BLASI she had been contacted by the FBI regarding her relationship with GIANCANA, and was uncooperative. BLASI then asked informant to appear at the Armory Lounge, Forest Park for a "conference" the same date. Informant stated there were several people at the Armory at the time she appeared, all conferring individually with BLASI. Informant unable to identify any persons there, but assumed they had all been either interviewed or contacted by the FBI, since that seemed to be the main topic of discussion. BLASI asked informant exact nature of contact by FBI, was told that her name had come up as one of GIANCANA's girl friends. BLASI at the time was drinking heavily, which according to the informant, was unusual. GIANCANA was not present, and indications were that he had left the area. (4)

BLASI advised the informant that he, BLASI, had been contacted by the FBI and he told the agents to "get lost". BLASI said he figures the FBI is "trying to get close to me since I am the closest person to SAM". Informant then accompanied BLASI to a new establishment, a private club located on Central Avenue in Cicero, Ill, where BLASI continued drinking. BLASI advised informant that GIANCANA had informant on his mind constantly and assured informant that he would get in touch with her as soon as he came back in town, advising the
