SAMUEL M. GIANCANA, AKA, AR. DAILY SUMMARY. JOHN TEETER PAREN PROTECT

IDENTITY END PAREN ADVISED ON JUNE NINE, ^{SIXTY}~~SEVENTY~~ ONE THAT GIANCANA
RENTED A HOUSE IN LAS VEGAS, NEV. FOR PHYLLIS MC GUIRE DURING THE
ENGAGEMENT OF THE MC GUIRE SISTERS AT THE SANDS HOTEL, COMMENCING
JUNE TWELVE LAST FOR ONE MONTH. GIANCANA IS ALLEGED TO HAVE STAFFED
THE HOUSE, AND INCLUDED ONE OF HIS OWN ASSOCIATES, ONE QUOTE CHOP
CHOP END QUOTE. LATTER PERSON UNKNOWN TO THIS OFFICE. GIANCANA IS BE-
