CG T-30 is former PCI who resides in an apartment building adjacent to the Armory Lounge, Forest Park, Illinois. She is only slightly acquainted with GIANCANA, however, knows him by sight. She has been in a position to observe and furnish the identities of automobile license numbers in and near the Armory Lounge. 11 CG T-31 is PCI who until recently was employed as card dealer and "lookout" at the Riviera Lounge, Niles, Illinois, which is an operation of GIANCANA through his lieutenant, ROCCO POTENZO. He has been extremely reluctant to furnish information; however, that which he has furnished has proved to be reliable. \ CG T-36 is a former PCI who was employed in the kitchen of MEO's Norwood House Restaurant, a one time hoodlum hangout. His whereabouts are now unknown. CG T-37 is former PCI who at one time was employed by MEO's Villa Venice Restaurant, Wheeling, Illinois. The information he furnished, although limited, was considered to be reliable. \\ CG T-50 is former PCI a Chicago Bondsman, Negro, who was in a position to furnish information relating to the activities of another Bondsman; IRVING WEINER, known to be closely associated with the hoodlum element. His information was known to be very reliable. CG T-68 is PCI time Chicago bookmaker who was recently severely beaten by Syndicate hoodlums in what turned out to be a successful attempt to bring him into the "syndicate" regarding his bookmaking activities. Although he is still a current PCI, the fact that he has "gone to the other side" makes his current reliability questionable, although the information he furnished proved to be reliable. () CG T-70 is PCI an old time Chicago confidence man who has a long record of arrests for larceny, forgery, etc. He was in an excellent position to furnish information regarding bookmaking wire services, and at one time was symbol number 5873-C. This matter was placed in a pending inactive status until recently in view of a Civil Suit which HIRSCH brought for false arrest from a Bureau apprehension in 1953. (A
