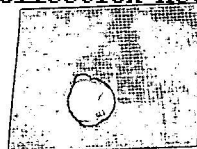
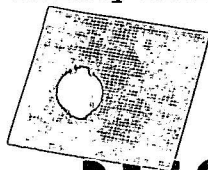

TRACING OF CADILLAC FROM FACTORY IS LEFT TO DISCRETION OF OO. ON MARCH 26, 1948 SAM BAKER SHOT AND KILLED A MAN AT LAS VEGAS, NEVADA, AND SHOULD BE CONSIDERED ARMED AND DANGEROUS. GIANCANA ARMED AND DANGEROUS. NEW YORK AND LOS ANGELES ADVISED BY AM.
